6.3.2. No Data Access: The Provider will not have access to the decrypted content of any data transmitted or stored as part of the services, except as required for legitimate technical support purposes and with the Client's explicit consent.

6.4. Client Responsibilities

7. Confidentiality

7.1. Confidential Information: Both parties agree to keep all confidential information received from the other party confidential and not to disclose it to any third party without prior written consent.

7.2 Exceptions: Confidential information does not include information that is publicly known or required to be disclosed by law.

8. Termination

8.1. Termination for Convenience: Either party may terminate this Agreement with 30 days' written notice to the other party.

8.2. Termination for Cause: Either party may terminate this Agreement immediately if the other party breaches any material term of this Agreement.

8.3. Effect of Termination: Upon termination, the Client will pay for all services rendered up to the date of termination.

9. Dispute Resolution

9.1. Governing Law: This Agreement will be governed by the laws of Madhya Pradesh (India).

9.2. Dispute Resolution: Any disputes arising under this Agreement will be resolved through Arbitration, and the decision will be binding.

10. Miscellaneous

10.1. Amendments: Any amendments to this Agreement must be made in writing and signed by both parties.
